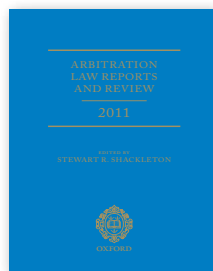


### Journal of European Competition Law & Practice - NEW
