

AUTHORS' RESPONSIBILITY AND CONFLICT OF INTEREST FORM

Journal of Biochemistry

At the point of submission, JB policy requires that each author must read and sign the statement on (A) Authors' Responsibility and (B) Conflict of Interest carefully. The copy of the completed form should be faxed to JB Editorial Office.

(A) Authors' Responsibility

Each author should read below statements and sign to agree that:

- 1) The contents have not been published elsewhere.
- 2) The manuscript is not under consideration for publication elsewhere.
- 3) All authors took substantial contribution to conceptions and design, execution or analysis and interpretation of data.
- 4) All authors took substantial contribution to drafting the article or revising it for important intellectual content.
- 5) All authors have given final approval of the submitted manuscript.
- 6) Scientific investigations involving human subjects, experiments are performed in accordance with the ethical standards formulated in the Helsinki Declaration of 1964
- 7) Animal experiments should follow the ethical standards formulated in the Helsinki Declaration, and measures taken to protect animals from pain or discomfort should be mentioned.

(B) Conflict of Interest

Journal of Biochemistry policy requires that all authors of all manuscripts sign a statement revealing:

- 1) Any financial interest in or arrangement with a company whose product was used in a study or is referred to in an article.
- 2) Any financial interest in or arrangement with a competing company.
- 3) Any other financial connections, direct or indirect, or other situations that might raise the question of bias in the work reported or the conclusions, implications, or opinions stated including pertinent commercial, governmental, private or other sources of funding for the individual author(s) or for the affiliated department(s) or organization(s) personal relationships, or direct academic competition. These relationships include: A) equity holdings or stock options, B) management/ Advisory affiliations, C) Paid consulting, and D) Patents.
- 4) Any declarable relationships for conflict of interest are stated in an attachment to this form.
