

JJCO Authors' Responsibility and Conflict of Interest

Each author must read statements on (A) Authors' Responsibility and (B) Conflict of Interest carefully. The completed form should be signed by all authors. Please fax the signed copy to JJCO as quickly as possible.

(A) Authors' Responsibility

- 1) The contents have not been published elsewhere.
- 2) The manuscript is not under consideration for publication elsewhere.
- 3) All the authors took a significant part in the work and approved the final version of the manuscript.
- 4) Investigations in humans are in accordance with the ethical standards of the responsible committee (institutional or regional) or with the Helsinki Declaration.
- 5) Studies of animal experiments include a statement in the compliance with the guidelines of the author's institution or the National Research Council's criteria (NIH No. 86-23).
- 6) All Authors must sign the Licence Form to grant Oxford University Press a licence to publish your accepted article, when the manuscript is accepted.
- 7) Authors have obtained all necessary permissions to publish any figures or tables in the manuscript, and assure that the authors will pay for any necessary charges.

(B) Conflict of Interest

Japanese Journal of Clinical Oncology policy requires that all authors of all manuscripts sign a statement revealing:

- 1) Any financial interest in or arrangement with a company whose product was used in a study or is referred to in an article.
- 2) Any financial interest in or arrangement with a competing company.
- 3) Any other financial connections, direct or indirect, or other situations that might raise the question of bias in the work reported or the conclusions, implications, or opinions stated including pertinent commercial, governmental, private or other sources of funding for the individual author(s) or for the affiliated department(s) or organization(s), personal relationships, or direct academic competition.
